A) \$1.50 per foot frontage (Local auto & machinery dealers - lot depth - approx. 20 - 40 ft.)

B) \$8.00 per foot frontage (Concessions and all other units/displays - lot depth; approx. 20 ft.)

Note: Frontage purchased must include isle (walk around) space.

Minimum charge on all outdoor space is \$80.00

Power: \$50.00

Water: \$25.00

Bookings: Full payment is required with booking.

Entry deadline: August 3, 2007

Entry to grounds: All exhibitors will be required to purchase a gate pass. A three-day pass costs \$18.00 and can be purchased by adding this cost to the cost of space rental.

The term of the lease shall commence at 9:00 a.m. Wednesday, August 8, 2007 and shall end at 12:00 midnight on Saturday, August 11, 2007. Exhibitors must have their display set up prior to 10:00 p.m. on August 8, 2007. Exhibitors shall agree to keep spaces intact until 12:00 midnight on August 11, 2007. No exhibitor shall be allowed to remove their respective displays prior to this time.

TURN OVER & SIGN BACK

Outdoor Exhibit Space - Conditions of Contract

1. Vegreville Agricultural Society (VAS) agrees to provide exhibit space as described on the front page of this contract.
2. Any items or services not included in the standard outdoor space shall be at the exhibitor's expense.
3. Exhibit space shall not be sublet by the exhibitor without permission of VAS.
4. VAS reserves the right to cancel this contract at any time.
5. VAS reserves the right to reject, prohibit or relocate exhibits for the good of the show.
6. The exhibitor is responsible for obtaining liability insurance for the period of the show, including move-in and move-out. The exhibitor is liable for any loss or damage.
7. The exhibitor agrees that no moving in or out of goods or dismantling of displays will be permitted during the entire run of the fair. The exhibitor also agrees to remove his exhibit, etc. from the fair grounds by the final move-out time. If unable to do so, the exhibitor agrees to make suitable arrangements or pay for such additional costs as may be incurred.
8. No exhibitor will be allowed to move in until payment has been made in full.
9. CANCELLATION POLICY: 75% refund will be issued on cancellation. 25% will be retained for administration costs.
